According to the description of Organic law 15/1999, of Personal Data Protection (LOPD) and its development norm, the person in charge of the web site, accordingly to the description of articles 5 and 6 of LOPD, informs all the web site users who give or will give their personal data, that these will be introduced into an automatized file registered in the Spanish Agency of Data Protection.

The users, by ticking the box, accept freely and with no restriction that their personal data shall be used by Efabind for the achievement of the following:

1. Communications sent by e-mail, fax, SMS, MMS, social communities or any other electronic or physical means allowing such communication. These communications will be related to Efabind's business and industrial activities. In this case, no third party will ever have access to personal data. All communications will be sent directly from Efabind.

3. Process orders, requests or any other type of demand made by the user from all types of contact made available to the use on Efabind's web site.

Efabind expressly informs and guarantees the users that their personal data will not, by any means, handed over to third parties, and if such is to happen, will request the user its express consent to do so.

All the data requested on the web site are mandatory as they are necessary to offer a top-quality service to the user. If all data is not entered, Efabind cannot guarantee that the information and services given will correspond exactly to the user's needs.

Efabind is thoroughly committed with the fulfillment of the Spanish regulations of personal data protection, and guarantees the fulfillment of all described obligations, as well as the total implementation of the security means described in article 9 of Law 15/1999, of Personal Data Protection (LOPD) and in the Development Rules of LOPD.

Efabind grants the user at all times the practice of their rights of access, correction, cancellation, information and opposition, according to the terms described in the current legislation. To do so, according to the description of Organic Law 15/1999, of Personal Data Protection (LOPD) the user will be able to exercise its rights by sending a written request, enclosing a copy of his ID using the following means:

The same way, the user will be able to cancel all types of services, in case they are created, of subscription by clicking the topic Cancel all electronic mail sent by Efabind.

The same way, Efabind applies all technical and organization means necessities to guarantee the security and integrity of the personal data they receive, in order to avoid their loss, modification and/or access by non-authorized third parties.

USE OF COOKIES AND ACTIVITY FILE

Efabind on its own or by means of a third party hired for measuring services, might use cookies while a user surfs on its web site. Cookies are files sent to the browser by means of a web server and whose purpose is to register the user's activities during his browsing time.

The cookies used by the web site will only be associated to an anonymous user and his computer, and will not give access by themselves to the user's personal data.

By using cookies the server where the web page is located might recognize the browser used by the user and make his browsing easier, granting previously registered users, for example, access to restricted areas without having to register each time they visit. Cookies are also used to measure audience and traffic parameters, as well as control progress and numbers of entries.

The user will be able to configure his browser to be informed about cookies reception and block their installation in his system. Please check your browser's instructions and manuals for further information.

To use the web site, the user does not have to allow the installation of the cookies sent by the web site, or the third party acting on its behalf, although the user will have to log on to each and every service when necessary.

The cookies used on this web site are, in all cases, temporary and their mere purpose is to make the next transmission easier. In no case will cookies be used to gather personal information.

IP ADDRESSES

The web site servers will be able to detect automatically the IP address and the domain name used by the user. An IP address is a number automatically assigned to a computer when connected to the net. All this information is registered in a file of server activity duly registered allowing subsequent data processing in order to obtain merely statistic measurements to know the number of pages impressions, number of visits to a web service, order of visits, access point, etc.

SECURITY

The web page uses information security technics commonly accepted by the industry, such as firewalls, access control procedures and cryptographic mechanisms, all of which in order to avoid non authorized access to the data. To achieve these means, the user accepts that Efabind shall obtain data to be used for the corresponding authentication of access controls.

All hiring process involving introduction of highly personal data will be transmitted through safe communication protocol, so that no third party can have access to information transmitted electronically.
